Loaves & Fishes of Northwest Oklahoma is a private, 501(c) 3 hunger-relief charity affiliated with the Regional Food Bank of Oklahoma. Located in Enid, we provide food to an average of 600 families each month.

As a client choice food and resource center, our clients get to decide which food items they take home each time they shop with us. Our facility is different from most food pantries because it contains a large commercial freezer and refrigerator, which allows us to accept and distribute more perishable food items, like fresh fruits and vegetables, dairy, and frozen meat.


